The audit covered the storage and distribution facility where packaged fresh fruits and vegetables are received, stored and shipped. There is no re-work or re-packaging. There are no product wash steps. The facility includes a total of 30,000 sq ft consisting of 5 cold rooms and the adjoining hallway where products are stored, along with a large break area and the receiving and shipping docks. There were a total of 30 warehouse employees, working during the audit with up to 35 available for particularly busy days. Employees include drivers for the fleet of company operated delivery trucks. Allergens are not handled at this site. Water from a municipal water system is used for facility cleaning and employee uses. A HACCP plan has been developed. There are no critical control points. The facility operates year-round. Participating in the audit were Sujit Dey, food safety manager and Matt Jardina, food safety director.
